**GENERAL PROVISIONS**

This application and the information contained herein is a request for the extension of credit from Woodson & Bozeman, Inc., a Tennessee corporation and/or any subsidiary thereof (collectively, along with their respective successors and assigns, hereinafter "WBI") to ("Applicant") for commercial business use only and Applicant certifies that the firm represented on this application is operating as such. The applicant authorizes WBI to obtain a written or oral business credit report and/or non-business consumer credit report from any credit reporting agency. The applicant further authorizes any bank or commercial business with whom the applicant is doing or has done any type of business to give any and all necessary information to WBI which will assist WBI in the credit investigation. The applicant further authorizes WBI to reinvestigate the applicant's credit status from time to time as WBI deems necessary.

If credit is extended, the undersigned (collectively, and hereinafter "Customer") agrees to pay WBI all debts incurred within WBI's terms of sale. Customer acknowledges that that if at some future time Customer deviates from WBI's terms of sale, WBI reserves the right to terminate any future extension of credit with Customer. Customer expressly waives all rights of exemption under the constitution and laws of the State of Tennessee and any other state, as to personal property and Customer agrees to pay all costs of collection or attempting to collect or secure any and all debts which Customer now owes or which Customer may in the future owe WBI for goods sold Customer or for services rendered including a reasonable attorney's fees or the unpaid debt so long as any of said indebtedness is due and unpaid. Customer also agrees to pay a FINANCE CHARGE OF 1½% PERCENT PER MONTH (ANNUAL PERCENTAGE OF 18%) on any unpaid past due balance except that, in no event, will Customer be required to pay, nor does WBI request that Customer pay more than the applicable state law permits, and, if Customer pays more than that is permitted under applicable state law, any amount paid in excess of the permissible amount will be applied to the principal balance due WBI. WBI is hereby authorized to deliver goods or perform services for the following at Customer's request and charge same to Customer's account and this shall continue until written notice to the contrary is given and accepted, which acceptance shall be evidenced by signature of WBI.

**UNCONDITIONAL PERSONAL GUARANTY**

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and in order to induce WOODSON & BOZEMAN, INC., a Tennessee corporation and/or any subsidiary thereof (collectively, along with their respective successors and assigns, hereinafter "WBI") to extend credit to ("Customer"), the undersigned Guarantor(s) (collectively, "Guarantor") does hereby unconditionally guarantee the due and punctual payment to WBI of any and all of Customer's liabilities and obligations ("Obligations") owed to WBI when the same became due. If there are more than one Guarantor, this Guaranty shall be and is a JOINT and SEVERAL obligation. Guarantor hereby waives all notice, presentment for payment, demand, protest, notice of protest, nonpayment and dishonor. Guarantor further waives any requirement that any action be brought against the Customer or that resort be had first against any collateral or other security before enforcement of this Guaranty.

Guarantor agrees that all guarantors, sureties, and endorsers shall be jointly and severally bound and liable under this Guaranty. The release of any one or more guarantors or the securing or release of any guarantors, sureties or endorsers or the taking or release, in whole or in part, of any other collateral as security for this instrument shall not release, alter or otherwise affect Guarantor's liability hereunder. Furthermore, Guarantor agrees that the extension, modification or amendment of any terms of Customer's Obligations, with or without notice to Guarantor, shall not release, alter or otherwise affect Guarantor's liability hereunder in any manner whatsoever.

In the event WBI or the holder of this instrument initiates any legal proceedings or incurs any costs or expenses, including but not limited to attorney's fees, in exercising or enforcing any of WBI's rights or remedies under the Credit Application and Guaranty ("Agreement"), Guarantor agrees such costs and expenses, including attorney's fees, may be added to the balance due and Guarantor shall be liable for payment of WBI's expenses and attorney's fees as an additional obligation under this Guaranty.

Guarantor hereby consents to and authorizes WBI to use or obtain from time to time one or more non-business consumer credit reports on Guarantor, as principal, proprietor and/or guarantor, in connection with the extension or continuation of business credit as contemplated by the Agreement or for any other purpose permissible under the Federal Fair Credit Reporting Act and/or other applicable law.

This guaranty shall be deemed made upon the execution and delivery hereof by Guarantor, upon each extension of credit by WBI to Customer and upon each incurrence of any Obligations by Customer.
